

# **Head of Fundraising (full or part-time)**

#### Overview

LawWorks is looking to recruit to this role to further grow and sustain income from trusts and foundations, and to enable us to diversify our fundraising approach, including legacy giving and securing corporate support and sponsorship. An early priority for the Head of Fundraising will be to work with the senior management team to identify additional fundraising capacity and support needs, building on activity and achievements to date.

#### About LawWorks

LawWorks is the operating name of the Solicitors Pro Bono Group. We are a charity working to connect volunteer lawyers with people in need of legal advice, who are not eligible for legal aid and cannot afford to pay. We also facilitate free legal advice for smaller not-for-profit organisations supporting a wide range of beneficiaries.

With support from the Law Society, we encourage, facilitate and celebrate pro bono across the solicitor profession and at law schools in England and Wales. We work primarily with solicitors (firms and in-house teams), and also with law schools and law students, and other legal and non-legal volunteers and organisations. LawWorks has around 150 member organisations including some of the largest City firms and international firms with an office in London, national, regional and local firms, in-house teams, law schools and charities.

LawWorks is a relatively small organisation with 23 members of staff (9 part-time) and a small team of volunteers and interns. 14 members of staff are usually based at an office in central London (currently working from home due to Covid-19, with a phased return to a new office), with other colleagues (mostly working from home) based in Wales, South West England, North West England, North England, East of England and the Midlands. LawWorks is introducing more flexible and remote working, which includes the option (for staff who would usually work from a London office) to work a number of days a week from home.

There are a number of key strands to our current work to support and facilitate probono:

- we support a growing network of around 300 local independent pro bono advice clinics across England and Wales. We work with lawyers, advice agencies, charities and others to establish or develop new clinics, and provide ongoing information and support, training and resources, for clinic volunteers and coordinators;
- our Not-for-Profits programme facilitates the provision of free legal advice for smaller charities and not-for-profit organisations, supported by volunteer lawyers from LawWorks' member firms and in-house teams. We also provide free online training videos for charities, covering many of the common legal issues they face;
- our 'secondary specialisation' projects support the development of more 'indepth' pro bono (e.g., bespoke casework and/or representation) in areas of social welfare law. This includes supporting solicitors to provide representation at social security appeal tribunals, an unpaid wages project, and (working with the charity Together for Short Lives) a project which provides legal advice for the parents and carers of children with life-limiting conditions:
- we support Pro Bono Connect, a project to connect solicitors and barristers working together pro bono on civil litigation cases;
- we have launched new online tools and digital platforms to connect people seeking legal advice with pro bono volunteers, including a website called 'Free Legal Answers' and the Pro Bono Portal UK (with Justice Connect, an Australian access to justice charity), with the potential for it to become a national 'one stop shop' for pro bono lawyers.

LawWorks is a partner organisation for the Litigant in Person Support Strategy, working with Law for Life, Support Through Court, RCJ Advice, Advocate and the Access to Justice Foundation. Funded by the Ministry of Justice, the Strategy works to improve information, support, advice and representation for individuals going to court or tribunal without a lawyer.

In addition to encouraging and supporting pro bono delivery, we also work to address barriers to justice and to provide a 'policy voice' for pro bono - for example, working to address regulatory and other barriers to pro bono volunteering, and working with our members and others to influence policy on legal aid, justice modernisation and other aspects of access to justice.

We are a busy and (for our size) complex charity, with a friendly team, a positive ethos and a commitment to doing all we can to ensure that LawWorks is a strong and efficient organisation and a great place to work.

### About the role of Head of Fundraising

Our current income comes from four main sources: annual grants from the Law Society and the Ministry of Justice, membership fees and income from trusts and foundations. A small proportion of our income comes from individual donations and events.

Over the last few years, we have been working with an external consultant to build our income from trusts and foundations. The Head of Fundraising will further grow and sustain this source of income, and enable us to diversify our fundraising approach, including major donors, legacy giving and securing corporate support/sponsorship.

This is a great opportunity for an experienced fundraiser. It is an ideal position for an individual seeking a role which captures the key elements of fundraising.

The Head of Fundraising will work closely with the Chief Executive and the fundraising consultant, and will be a member of the LawWorks Management Team.

There is a commitment to further develop LawWorks' fundraising and income generation capacity, building on progress and tangible achievement. An early priority for the Head of Fundraising will be to work with the senior management team to identify additional fundraising capacity and support needs (e.g., this may include recruiting an additional fundraiser or support officer which the Head of Fundraising will line-manage).

The post holder will have clear fundraising priorities, but we are also looking for someone willing to lend-a-hand to support key events and able to work well as part of a relatively small organisational staff team.

Flexible working arrangements will be available (including days during the week working from home) and while some very occasional evening work may be required, time off in lieu will be given.

The option to be home-based, if outside reasonable commuting distance to London, will also be available.

LawWorks is registered with the Fundraising Regulator.

#### **Role description**

- To produce (working with the senior management team) an annual fundraising strategy.
- To identify and secure sources of income from trusts, foundations and statutory bodies.
- Continue with the development of legacy giving, including as part of a major donor programme.
- Seek corporate donors and sponsors and (working with colleagues) help to support fundraising events, such as the annual carol concert (organised jointly with the charity Advocate).
- Provide consistent relationship management for existing and new funders, and ensure reporting requirements are met.
- Liaise with people undertaking fundraising events and activities on behalf of LawWorks, for example, runners in the London Marathon.

- Provide stewardship for our individual donors (for example by producing two newsletters a year).
- Achieve annual fundraising targets.
- Provide regular updates and reports and contribute to reports to the management team and Board of Trustees on fundraising activities.
- Working with LawWorks policy and programmes teams, share with key funders the narrative of our impact and the stories of people helped through LawWorks' programmes.
- Ensure that donor/funder records are accurate and up to date.
- Ensure that relevant fundraising information on our website (e.g., the donate page) is kept up to date.
- Other reasonable duties relevant to the role, to support LawWorks in achieving its strategic outcomes and ensure effective impact and business operations. tasks and duties.
