

## LawWorks membership fees 2025

Our membership fees vary by type of organisation and factors such as the number of fee earners. There are a number of categories, including for in-house teams, smaller firms, legal aid firms and not-for-profit organisations and charities.

Membership is for 12 months – the following are the fees for joining/renewal this year. If you decide to join part way through a calendar year, the membership fee will be for a pro rata amount.

### Firms with their Head Office in London:
